### ELIGIBILITY CRITERIA FOR THE BIDDER

A) Online bids from reputed and financially sound bus body and ship fabricators (bidder) are invited for minor repairing of bus body, seats and full body painting.

- 1) A bidder should be a firm that is a private entity, a state owned enterprise or any institution liable for the execution of the entire contract in accordance with contract terms.
- 2) The bidder must have their Registered Office in India.
- 3) The bidder should have minimum 3 years' experience in fabrication of MS/ Aluminium bodies for Buses, Vans, Ships etc. to STU / Government organizations.

B) The Bidder qualified for criteria mentioned in Sl. A, will be eligible for submission of Technical proposal as mention in Sl. B.



## SECTION – B SPECIAL TERMS AND CONDITIONS

- 1) The work has to be carried out in the premises of SWL at 1 Foreshore Road, Howrah 711 102.
- 2) Duration of Work/Job:
  - a) For each bus the maximum time will be 20 days from the date of arrival of the bus from the respective depot.
  - b) The completion time for the total allocated buses will be 270 days from the receipt of formal Purchase Order.
- 3) Bid Validity:

Quoted rate will be valid for 12 months (365 days) from the date of opening of Financial Bid.
- 4) Part Order acceptance:

SWL, reserves the right to place order to the successful bidder/bidders at L-1 rates segregated with minimum 30 buses in phases per bidder. Order may be placed to the successful bidder in instalments. However in case the performance of repairing of successful bidder is not found satisfactory, SWL reserves the right to make its choice from the next bidder.
- 5) Delivery Schedule & Liquidated Damage (L.D.):

Scheduled Delivery of each bus is 20 days from the date of receipt of bus from SWL/Depot. If the bus is not delivered in scheduled time, a penalty of ₹ 150/- per day per non-supplied bus will be deducted/ levied from the bill as liquidity damage.
- 6) SWL's Scope of Supply:

Working space, water, electricity (as long as CESC supply is available), lighting, materials handling facilities as required.
- 7) Contractor's Scope of Supply and Work:
  - a) Providing of skilled, unskilled workmen, competent site-in-charge/co-ordinator well conversant with the job.
  - b) Providing of all tools & tackles including air compressor and painting spray gun, sewing machine, necessary needles & threads etc.
  - c) All materials including paints (primer & finish), rexine, 12 mm thick plywood, HD foam and any other materials in connection with the stated job.
  - d) Work to be carried out as per the Job Schedule stipulated in Section C.

- e) Work done certificate to be prepared and collected from WBTC duly signed by their authorised representative.
- f) Preparation/arrangement for delivery challan during delivery of each bus to the respective Depot and handover to SWL.
- g) Providing of welders, gas cutters etc. for the necessary repairing work.
- h) Necessary welding machines and gas cutting sets including electrodes, gas and other consumables.
- i) Any other work and minor materials beyond the scope of supply/work of SWL not indicated above but required for successful completion of the work are to be considered within the scope of the vendor.

**Note:**

- a) The successful bidder has to take-up the job immediately on finalisation of the contract/order on receipt of LOI/P.O.
- b) Utmost care has to be taken during execution of the job to avoid any damage/loss of the vehicle including machineries installed therein. Wilful damage has to be compensated in full.
- c) Safety of persons engaged in the job is vendor's responsibilities and formalities are to be observed as per rule.

8) Variation in Work:

SWL shall have the right to make variation in the BOQ of the tender at the time of execution of the work. In case of upward variation in the item quantity, contractor will be bound to execute the work as per the BOQ approved rate.

9) Inspection:

By SWL and WBTC as and when required, in stages and also after completion. The jobs are to be carried out as per direction of SWL and with close liaison among departments.

10) Price:

To be quoted in INR per unit basis. GST will be extra as applicable.

11) Taxes:

The bidder shall be solely responsible for the payment of GST and other taxes, if any levied by the Government and other local bodies from time to time.

12) Work Done Certificate:

Work done certificate based on the actual work done to be submitted duly signed by SWL and WBTC authorised representative.

13) Terms of Payment:

- a) 90% payment will be done within 30 (thirty) days after receipt of completed buses on receipt of three copies of tax invoices and other related papers/documents completed in all respect.
- b) Remaining 10% will be released after completion of 1 year guarantee period.

14) Risk Purchase:

In case of delay in execution of the work beyond the contractual completion period, SWL reserves the right to out-source the job from any other firm at the risk and cost of the vendor.

15) Prevention of Damage:

Utmost care has to be taken during work at SWL premises to avoid any damage/loss of company's materials, machineries. Wilful damage has to be compensated in full. Safety of sub-contractors men and materials shall their own responsibility. All rules applicable for working within PSU premises are to be adhered to.

16) Safety:

Proper safety of contractor's workmen will be completely under the responsibility of contractor at shipyard of SWL.

17) Arbitration:

## SECTION – C TECHNICAL SPECIFICATIONS

### JOB SCHEDULE FOR BUS BODY REPAIRING & PAINTING:

1) Body:

Full bus body (outside & inside) patch repairing to be attended.

2) Passenger Seats:

Seat with backrest are to be repaired with new rexine, 12 mm thick plywood & HD foam for standard buses/suitable cushion with fabrics for plastic moulded seats as per requirement.


3) Paintings:

All painting surface are to be thoroughly degreased with suitable organic solvent, followed by mechanical roughening so as to produce a surface on which the primer & paints can adhere to. The surface should then be spray-painted & finished as per WBTC specification with air drying synthetic enamel of high grade & approved quality. The exterior & interior paintings shall be in four coats including one coat of primer, one coat of filler & two coats of finished paints.

4) Special Note:

Outside body & inside body paints will be of synthetic enamel (ICI/ BERGER/ ASIAN/ DELUXE/ Equivalent). Primer will be same make. Advertisement portion area is given below (model wise):
