## SECTION – B SPECIAL TERMS AND CONDITIONS

#### 1) Scope of Supply:

Scope of supply & technical specification/requirement shall be strictly as per technical specification requirement stated therein as well as terms & condition of NIeT. #### 2) <u>Price</u>:

To be quoted in INR per Metric Ton (MT) basis. Variation of weight upto  $\pm 5\%$  is accepted. The tender will be settled on total value of offers comprising of all the items.

#### 3) <u>Terms of Price</u>:

Quoted price shall be firm and fixed till full execution of order and shall be on F.O.R. SWL Howrah basis inclusive of all charges except GST. Unloading of materials is entirely vendor's responsibility.

4) <u>Taxes</u>: Goods and Services Tax (GST) is extra as applicable at the time of supply.

#### 5) <u>Terms of Payment:</u>

100% payment within 30 days after supply and acceptance of the materials at SWL yard.

#### 6) Place of Delivery/Work:
