## SECTION – B SPECIAL TERMS AND CONDITIONS

1) Scope of Supply:

3) Terms of Price:

Quoted price shall be firm and fixed till full execution of order and shall be on F.O.R. SWL Howrah basis inclusive of all charges except GST. Order for part of the items should be acceptable to the bidder.

4) Taxes:

G.S.T. extra as applicable at the time of supply.

5) Terms of Payment:

100% payment within 30 (thirty) days after supply & acceptance of the materials at SWL yard.

6) Place of Delivery/Work:

9) Inspection:
